# Merge Purchase Orders (PO)

---

The Merge PO function allows you to merge purchase orders together from the same vendor.

## Set up a Merged Purchase Order

---

1. Log in to the Data Center to display the Data Center Ribbon Menu.
2. Click the **Receiving** tab to display the Receiving Ribbon Menu.
3. Click the **Receiving** button to display the Receiving screen.
4. Your list of Purchase Orders will display.
5. Select a Vendor.
6. Search by PO's or Vendor Order# to filter to the desired purchase orders.
7. Click the boxes under the Merge column to select the Purchase Orders to be merged.
8. The column heading [Merge] will become a button. Click **Merge** button.
9. A window will display. Use the checkboxes within the grid to select the primary PO.

**Note:** Merged Purchase Orders CANNOT be unmerged.

10. Click **Submit**.
11. Click the "new" Purchase Order to open the **Receiving** screen.
12. Receive product.

**Note: FOR ACUSPORT ORDERING ONLY:** No matter how you create an order with AcuSport; whether it's through E-online or calling your Sales Pro, AXIS will create a PO and send it to the Receiving Tab. If the purchase order changes, the information will automatically update to ease the receiving process when the product arrives in the store

# Enhancements

## VeriFone Security Update

VeriFone Inc. provides the software and hardware used by AXIS Retail Management System to process credit/debit card transactions via the MX credit card terminals. VeriFone has notified RTG of an upcoming update to improve the security of the VeriFone Point software. The AXIS 2.14 Patch contains code critical to the continuous and reliable use of credit card payments once the VeriFone Point software has been updated. To ensure uninterrupted operation of card processing services, **apply the 2.14 Patch to the AXIS RMS before February 12.**
